INTRODUCTION

Unibasq undergoes external evaluation every five years in order to remain full member of ENQA (European Association for Quality Assurance in Higher Education) and ensure its renovation in the EQAR registry. After a throrough reflexion and planning period, Unibasq issued a self-evaluation report reflecting on the achievement of the european standards and guidelines for quality assurance (ESG 2015) that sat the foundations of ENQA's 2018 evaluation, the result of which will be disclaimed at the beginning of 2019.



GENERAL MANAGEMENT: BODIES

Governing Board

The Governing Board held three ordinary meetings in 2018 (21st March. 3rd July, and 19th November). The summaries of the minutes of these meetings are published in Unibasq's webpage.

Belén Urosa Sanz and Patricia Pol have taken over Esther Giménez-Salinas and Guy Haug in the Governing Board in 2018.

Advisory Body

The Advisory Body met on four occasions in 2018 (11th April, 24th May, 27th June, and 9th November). The corresponding summaries of the minutes of these sessions can be found in Unibasq's webpage for decision-making or issue-solving matters that this body deals.

The Advisory Body of Unibasq welcomed Cristina Iturrioz, Manuel de León, Salustiano Mato, Diego José Sánchez and Alfonso Novales, members who take over the positions vacated by Joaquín Losada, Cesar Arrese-Igor, Cristina de la Cruz, Teresa Riesgo and Gemma Espigares. The mission of Unibasq is to contribute to the improvement and innovation of the Basque University System.

2. EVALUATION ACTIVITIES PERFORMED BY UNIBASQ

The main activities of the Agency throughout 2018 are the following:

I. TEACHING STAFF

a) ACCREDITATION OF THE TEACHING STAFF

The Governing Body of Unibasq approved on 16th of October 2017 the Call for General Accreditation 2018, which was published on the Official Bulletin of the Basque Country on 26th October 2017, with the purpose of evaluating and accrediting research doctor staff, associate teaching staff, aggregate teaching staff, full-right teaching staff, research staff and Doctor teaching staff of the private universities.

This evaluation was executed in its entirety within the corresponding year, having received 777 applications (694 in 2017), of which 734 (649 in 2017) were accepted for evaluation, and which are distributed according to their field of knowledge as shown in the following chart:

The Protocol for the Evaluation and Accreditation of Teaching and Research Staff and Private University Teaching Staff with a Doctors Degree was approved on 9th November 2018.

Later, on 19th November, the Governing Board passed the Ordinary Call for 2019.

b) RESEARCH

SIX-YEAR TERMS

The Call for the Evaluation of Research Activities 2017 was assessed in 2018, receiving 136 applications that amounted to 156 periods to be evaluated, resulting in 141 researchsteps of six-year-terms receiving favourable evaluation.

This evaluation is carried out by ANECA under a collaboration agreement between the Spanish Agency and Unibasq.

A new call was published in December 2018 to be executed throughout 2019.



IKERTRAMOS

Deusto University requested the evaluation of 84 applications in 2018, to which 33 more from UPV/ EHU were added at the end of the year, to be executed in 2019.

IKER22

In 2018 22 applications were evaluated (11 of them from 2017) upon request from UPV/EHU, and 2 more will be done in 2019.

c) COMPLEMENTARY PAYMENTS

A new Protocol for the Evaluation and Distribution of Complementary Payments for the Teaching and Researching Staff of the UPV/ EHU was approved in 2018 (BOPV 07/09/2018). 141 research steps of six-year terms have received favourable evaluation in 2018. 02. II. DEGREES

EX-ANTE ACCREDITATION/ AUTHORISATION

Unibasq evaluated 7 proposals for Master's Degrees (4 from Musikene, 2 from UPV/EHU and 1 from Deusto University) in addition to one proposal for Degree from Deusto University and one for a Doctor's Degree from UPV/EHU.

Two further ex-ante accreditations were executed for two Master's Degrees (one form UPV/EHU and one from Mondragon University), and one for a degree that will be evaluated in 2019.

MODIFICATION

Three Degrees were evaluated in 2018 (1 from UPV/EHU, 1 Deusto University, and 1 from Mondragon

University), and 4 Master's Degrees (2 from Mondragon University, 1 from UPV/EHU, and 1 from Deusto University), having received their corresponding Modification Reports.

Additionally, one Master's Degree from Deusto University received an ex-ante evaluation to be completed in 2019.

MONITORING

66 Monitoring reports were issued in 2018 (45 from UPV/EHU, 12 from Deusto University, and 9 from Mondragon University).

ACCREDITATION RENEWAL

The following calls were carried out in 2018:

Unibasq issued 66 Monitoring reports in 2018.



Call V:

Reports for the renovation of TEC were drawn, resulting in the accreditation of 15 degrees: 13 from UPV/ EHU (2 Degrees and 11 Master's Degrees) and 2 Master's Degrees from Deusto University.

Call VI:

Beginning in October 2018, it has received 57 Degrees to be evaluated: 51 from UPV/EHU (1 Degree, and 50 Master's Degrees) and 6 from Deusto University (1 Master's Degree, and 5 Doctor's Degree).

For the evaluation of this call, Unibasq created 17 Visiting Panels, 10 of which having fulfilled theirs tasks in 2018, and the rest of them, together with the corresponding renewal reports to be completed in 2019. The AUDIT Committee has taken part in both evaluation calls, revising standard 3 of the QMS.

DUAL

The objective of this programme is to evaluate the proposals for Degrees and Master's Degrees proposed for the recognition of "Dual training or Alternation University-Entity".

Unibasq undertook the evaluation of 27 proposals submitted by the universities for school years 2018-2019. 26 Degrees were evaluated in 2018, with one degree pending for 2019.

INTERNATIONAL

The purpose of this programme is to evaluate the proposals of Degrees and Master's Degrees submitted for the recognition of the Internationalisation seal. The draft for a Protocol for Internalisation was issued in 2018, 2019 being the year in which it is expected to be finally approved.

CERTIFICATES AND DIPLOMAS

23 proposals from UPV/EHU were evaluated in 2018.





III. INSTITUTIONAL

AUDIT

UPV/EHU presented 5 evaluations for design in 2018 within the frame of the AUDIT programme, adding two more by the end of the year that will be executed in 2019.

Three Certification Reports were issued in 2018 (1 for UPV/EHU, 1 for Deusto University, and 1 for Mondragon), and three Panel Visits for the implementation of the QMS (2 for UPV/EHU, and 1 Deusto University), one of them corresponding to the Faculty of Psychology (UPV/ EHU), a joined visit with the Euskalit Panel according to the MGA, obtaining the Silver A.



DOCENTIA

In 2018 Unibasq started the assessment for the Certification of the Evaluation of the Teaching Activity of the UPV/EHU (DOCENTIAZ), following the model of DOCENTIA. The visit to UPV/EHU of the Docentia Committee of Unibasq was carried out in November.

The preliminary reports for the Evaluation of the Implementation of the Evaluation of the Teaching Activity for the teaching staff of Mondragon University and Deusto University.

PROGRAMME-CONTRACTS

Upon request from the Basque Government, the reports on the fulfilment of the Programme-Contracts signed between them and the three universities, and submitted by the latter were evaluated for the period 2015-2018.

RECOGNITION OF UNIVERSITIES

A Committee for the Recognition of Universities was created in 2018, issuing a report for the evaluation of the Memory presented for the creation of a new university. In 2018 Unibasq started the assessment for the Certification of the Evaluation of the Teaching Activity of the UPV/EHU.

Unibasq's Director, Eva Ferreira, was appointed Vice-President of the Board of ENQA, and Internationalisation and Projects Manager Eva Fernández de Labastida was been elected for the Board of ECA (European Consortium for Accreditation).





INSTITUTIONAL ASSESSMENT

Unibasq offered assessment to public administrations with regards to degrees that may access certain positions in Public Employment Offers.

REACU

The Agency took part in the three encounters of the Spanish Net of Quality Assurance Agencies (REACU) that were held in 2018.

Students Consultive Committee

The Committee met on two occasions, and one training workshop on quality issues was imparted.

ICU Report

Unibasq worked with the rest of Quality Assurance Agencies of Spain in the ICU 2017 report.



Cooperation with Euskalit

Unibasq participated in the External Evaluation of the Basque Network of Technology Parks, following the Advanced Management Model of Euskalit, and as Evaluator for the Bikain Label for several institutions and organisations.

Quality Innovation Award 2018

Unibasq cooperates with EUSKALIT in the dissemination of the activities of the universities and in the selection of experts for the evaluation of the candidates for the local phase. 17 evaluations were done in 2018.

Agreements signed:

- Agreement of cooperation between Unibasq and UPV/EHU for the evaluation of University and Research Institutes.
- Specific agreement for the evaluation of the Law Degree of the University of Aconcagua.
- Cooperation Agreement between Deusto University and Unibasq for the evaluation of Research Periods of the Permanent and Non-permanent teaching staff of Deusto University and Associated Centres.
- Agreement between FIBAA (a German Quality Assurance Agency), and Unibasq for the cooperation in the field of Quality Assurance and Accreditation in Higher Education.

At least three training activities were carried out.


f. Equality


COST DISTRIBUTION PER AREA (euros)
